3. The Recognized Organizations authorized to issue the Maritime Labor Certificate and the Declaration of Maritime Labor Compliance Part II.

4. The ILO provides some training and workshops through its Maritime Labor Academy with respect to the MLC, 2006 including certification of people that could be national or regional level trainers of inspectors on the MLC, 2006, therefore, each RO surveyor authorized through this circular, must be accredited as a maritime labor inspector by a ILO trainer of trainers (Tot) or a trainer certificated by a Tot.

5. The General Directorate of Merchant Marine shall regulate all matters related the issuance and validity of the maritime labour certificate (interim and full) through the Circular MMC 269.

6. The Classification Societies and the Recognized Organizations that are authorized after the publication of this Circular shall be included in the current list.
